This Consent shall be binding upon me, and my/my child(ren)’s heirs, personal representatives and assigns, and shall be governed by and construed under the laws of the State of Florida without regard to conflicts of laws principles. Venue for any legal action arising out of or in connection with this Consent shall be in Orange County, Florida, and jurisdiction shall be vested exclusively in the Circuit Court of the Ninth Judicial Circuit in and for Orange County, Florida or, if appropriate, in the Federal District Court for the Middle District of Florida, Orlando Division, and I waive my/my child(ren)’s right to a trial by jury. This Consent constitutes the entire agreement between the parties hereto with respect to the subject matter of this Consent and supersedes any and all previous agreements, communications or representations between the parties, whether written or oral, with respect to such subject matter.
