	<b>Description:</b> Detailed description of work has been provided and is consistent with permit type and workclass.	Required
	<b>Project Valuation:</b> Provide the project valuation applicable to this permit. <b>Note: Projects with multiple permits will need to breakdown the project valuation and apply specific valuations for each permit that equal the total project valuation.</b>	Required
	<b>Contacts:</b> Provided contact information for Applicant, Owner, Owner Builder or Contractor (i.e. name, address, phone and email).	Required
	<b>Owner:</b> Ensure the owner provided is consistent with the owner displayed on the Orange County Property Appraiser website. <b>Note: If the property ownership has recently changed, please provide a warranty deed.</b>	Required

	<b>Contractor:</b> When providing a contractor, please provide the required documentation (i.e. license, general liability & worker comp. insurance, and BTR) is updated. <b>Note: You can update Contractor Certifications through our CSS Permitting Interface. Documentation	<b>Limited Power of Attorney Required:</b> If you are a contractor or agent applying for, communicating on behalf of and/or representing the homeowner or property owner for the purpose of this permit application, a notarized Limited Power of Attorney Form is required to be signed by the contractor/agent and the homeowner/property owner and uploaded in the CSS portal as part of your application. 	<b>NOC:</b> Copy of the recorded Notice of Commencement (if value is over \$5,000 most permits or \$15,000 for HVAC) is provided. If not, please indicate in the "If N/A Provide Reason" box that the NOC will be provided prior to first inspection.		
	<b>Document Naming Convention:</b> Ensure all attachments are under proper naming convention as outlined on the City's website.		Required
	<b>Pool Barrier Affidavit</b> is completed, signed, notarized and uploaded with the permit application. <a href="https://www.itsmymaitland.com/428/Permit-Applications">https://www.itsmymaitland.com/428/Permit-Applications</a>		Required
	<b>Flow calculations</b> (TDH) for pool equipment (this is a one or two sheet formula page) showing the pipe size and flow rates for system.		
	<b>Product Specifications:</b> Along with the flow calculation sheet there will be accompanying manufacturer sheets for the pump and main drain and, if applicable, pool heater.		
Certified Survey	<b>Sub Trade:</b> Pool permits are required to provide a Electrical Sub-Trade Permit. If applicable, the Pool permit shall not pass sufficiency prior to the submission the electrical permit.		Required
	Survey is to scale and includes entire property displayed, provides legal description, provides north arrow, existing structures, location of all easements and right-of-ways and label all streets		
	Survey displays Normal High Water Elevation (NHWE) and the water setback from the NHWE, if applicable.		
	Survey displays (if applicable) the 100 year flood line and flood zone category and wetlands delineated, if any.		
	<b>Combined Plan Set:</b> Plan Set submitted under property naming convention and all sheets are combined and submitted as one (1) pdf document.		Required
	<b>Combined Plan Set:</b> Plan is drawn to scale and a north arrow, entire property displayed, required yards and setback information are displayed and adjacent streets and water bodies are labeled.		Required
	<b>Combined Plan Set:</b> Plan shows all existing and proposed structures on the site.		Required
	<b>Combined Plan Set:</b> Plan shows location of mechanical equipment (e.g. A/C, pool equipment, generator, etc.)		Required

<b>Plan Set</b>	<b>Commercial/public pools:</b> Copy of State of Florida approval and plans review comment form is provided.		Required
	<b>Engineered Plan Set:</b> Plan sets submitted for eReview shall be digitally signed and sealed. Once the plans are approved through eReview, the City will electronically stamp the plan set, make the plan set available online and send an email request for approved plans to be on the job site. The City requires one approved plan set for the office and one for the job site. 	<b>Do Not Submit Secured Documents:</b> Ensure plan set or documents is not submitted in a secured state preventing the ability for staff review.		Required
